

दिल्ली हाई कोर्ट से भाजपा को झटका

# केग रपट पर विस का विशेष सत्र बुलाने का निर्देश देने से इनकार

नई दिल्ली, 24 जनवरी (भाषा)।

दिल्ली उच्च न्यायालय ने शुक्रवार को कहा कि आम आदमी पार्टी (आप) सरकार ने राज्य विधानसभा में कैग रपट पेश करने में अत्यधिक देरी की है, लेकिन विधानसभा की विशेष बैठक बुलाने का निर्देश देने से इनकार कर दिया और कहा कि चुनाव से कुछ दिन पहले विशेष बैठक बुलाना अव्यावहारिक है। न्यायमूर्ति सचिन दत्ता ने हालांकि इस बात पर जोर दिया कि आडिट रपट पेश करना संविधान के तहत अनिवार्य है और उन्होंने निर्देश दिया कि दिल्ली सरकार चुनाव के बाद इन रपटों को यथाशीघ्र विधानसभा में पेश करे।

अदालत ने कहा कि यह बिल्कुल स्पष्ट है कि विधानसभा के समक्ष कैग रपट प्रस्तुत करने के लिए अपेक्षित कदम उठाने में दिल्ली सरकार की ओर से अत्यधिक विलंब हुआ है। आदेश में कहा गया है कि ऐसी स्थिति में (जब मौजूदा विधानसभा का कार्यकाल समाप्त होने वाला है), विधानसभा की विशेष बैठक आयोजित करना अव्यावहारिक होगा... यह देखते हुए कि विधानसभा अपने वर्तमान कार्यकाल के अंतिम चरण में है, पीएसी (लोक लेखा समिति) द्वारा इस पर विचार अब नवनिर्वाचित विधानसभा की बैठक को फिर से बुलाए जाने के बाद ही होगा। इसमें कहा गया हैं कि अदालत याचिकाकर्ताओं के इस अनरोध

न्यायाधीश डीके उपाध्याय एवं न्यायमूर्ति तुषार राव गेडेला की पीठ ने विधानमंडल में रपट पेश करने के संबंध में संविधान के अनुच्छेद 151 का संज्ञान लिया और कहा कि जनता को जानने का अधिकार है, लेकिन यह संवैधानिक प्रावधान का

उल्लंघन नहीं हो सकता। अदालत ने कहा कि अनुच्छेद 151 एक आवश्यकता है और वर्तमान मामला महत्वपूर्ण है, क्योंकि कुछ जानने की कोशिश कर रहे नागरिकों को संवैधानिक प्रावधान का सामना करना पड़ रहा है। याचिकाकर्ता की ओर से पेश वरिष्ठ अधिवक्ता ने दलील दी कि नागरिकों को सूचना का अधिकार अधिनियम एवं संविधान के अनुच्छेद 19 के तहत जानने का अधिकार है।




